

Welcome Gift \$100 - Terms and Conditions

1. General Overview

The "Welcome Gift \$100" promotion is offered by **Primus Markets INTL Limited (the "Company" or "FXPRIMUS")** to reward new and existing clients who complete key onboarding steps within 31 days of registration. The promotion encourages account verification, initial funding, and trading activity.

- 2. Eligibility
- This Offer is open to **new and existing clients**.
- Clients must fulfill each step sequentially to be eligible for the respective bonus.
- Bonuses will be credited to clients' trading accounts after completion of all three stages within 31 days of registration and upon meeting all bonus criteria, including the cumulative trading requirement of 3 lots.
- Each client is eligible for **one (1) bonus** under this promotion.
- This Offer cannot be combined with any other Offer.
- The Offer is **not available to synthetic accounts**.
- Only self-directed trading accounts are eligible.
- The promotion is applicable only for trading accounts denominated in USD or its equivalent currency.
- The total bonus amount a client can receive under this program is **limited to \$100 or currency** equivalent.
- Clients must comply with FXPRIMUS's general terms and conditions to be eligible.

3. Bonus Breakdown and Requirements

The bonus is structured as follows: a) **Profile Completion Bonus**

- Amount: USD 20
- **Requirement**: Complete all personal details, including email verification, contact information, and trading preferences.
- **Eligibility**: Clients completing their profile for the first time.

b) KYC Completion Bonus

- Amount: USD 30
- Requirement: Submit and verify all required KYC documents (e.g. Proof of ID, Proof of Address).
- **Eligibility**: Clients submitting verified KYC documents for the first time.





c) First Deposit Bonus

- Amount: USD 50
- **Requirement**: Make a first deposit of **at least USD 100** after completing profile and KYC.
- Eligibility: Deposit must be made within 31 days from registration.

Maximum Bonus: USD 100 (combined total of all three components)

4. Trading Requirement

To unlock the full bonus for withdrawal or further use in trading:

• Clients must trade a **cumulative volume of 3 standard lots** within the 31-day eligibility period.

5. Withdrawal Conditions

- The bonus is **non-withdrawable** unless all criteria (including the 3-lot trading requirement) are fully met.

6. Account Restrictions
